Center of Excellence (CoE)/IRISET invites interested agencies with relevant expertise and experience in radio frequency surveys to submit their Expression of Interest (EOI) for empanelment. This empanelment is for the works which primarily involve conducting comprehensive radio frequency surveys, including but not limited to:

- 1. Radio frequency spectrum analysis and mapping.*
- 2. Identification of interference sources and resolution strategies.*
- 3. Evaluation of signal propagation characteristics.*
- 4. Assessment of signal strength and quality.*
- 5. Compliance with regulatory requirements and guidelines.*
- 6. Recommendation of optimization measures for network performance improvement.*

Detailed scope of work, including but not limited to:-

The steps involved in a radio survey for LTE networks typically include the following:

- 1. Planning and Preparation:*
 - Define the survey objectives, such as coverage analysis, capacity planning, interference identification, or optimization.*
 - Gather relevant network information, including site locations, antenna configurations, and frequency bands.*

Example for item No. 5 (In case more than one firm has responded):-

i. Considering two firms have responded, one having 8 Number of eligible Key personnel & other having 6 Number of eligible Key personnel. Base reference for this credential is 15. The Marks allotted to first company will be = 15 and to second company will be = $(6/8) \times 15 = 11.25$

Section 9
SHORTLISTING CRITERIA

2. CoE/IRISET may waive any minor informality or non-conformity or irregularity in any bid, provided such waiver does not prejudice or affect the relative ranking of any other bidder.
3. Any effort by a bidder to influence CoE's bid evaluation, bid comparison or contract award decisions may result in the rejection of the bidder's bid and forfeiture of the bidder's EMD if any.
